

**ARREST-WARRANTS : Step by step instructions, how to proceed**  
**These are only recommendations, the procedure is up to each sovereign individual.**

1. A Live-Life Claim (see template on WTP-Switzerland website), or short video: "I do not consent".

- If you already have a Live-Life Claim, please scan it.
- Send the scan as a PDF to [wtp-teamswitzerland@proton.me](mailto:wtp-teamswitzerland@proton.me).
- The Live-Life Claim / Video will be published on the We The People - Switzerland website / Rumble, although certain info can be obscured on the LLC, see examples.
- **We stand only for living, spirited men and women who show their faces ; no anonymity.**

**Only when you have completed point 1 can you proceed to point 2.**

2. What to do with offers that arrive in my mailbox?

Step 1:

- Variant 1: Use the "Example for all to send" letter template to return the offers (e.g. payment orders, etc.)

Step 2:

- Variant 2: Stick the QR code on the window/address of the unopened envelope, write "return" on the envelope and put it back in the postbox.
- Variant 3: Fireplace or paper bin ;-).

3. When to issue an invoice?

Step 3:

- At your own discretion ; it is your responsibility.
- **The 3 times rule is important (Step 1-3)**
- Variant 1: First send the letter "Example for all to send", then if there is further harassment, an invoice with a deadline for payment. If still no payment send a reminder, again with a deadline for payment and with the information that in the event of non-payment, an arrest warrant will be issued without further notice.
- Variant 2: Invoice, reminder 1, reminder 2 with notification of arrest warrant.

4. The evidence on which the arrest warrant is based:

Step 4:

- **The 3 times rule is important and that the QR code Global Constitution / Judicial Notices is sent ( see Nr.3).**
- Brief description of the situation.
- Evidence, e.g. correspondence or letters from courts, police, tax authorities, etc., which make or have made demands.
- **Contact person (first name and surname, NO MISTER, MADAME, DOCTOR, ETC.)**  
**"Function" (e.g. head of the tax office)**  
**Company name (e.g. tax office)**  
**Full postal address (NO POSTBOX !)**
- Everything together, bundled in a PDF file, will be published.

5. The arrest warrant:

- You have to create the arrest warrant **yourself** and send it as a PDF to [wtp-teamswitzerland@proton.me](mailto:wtp-teamswitzerland@proton.me).
- After the security check, post the arrest warrant as a PDF in the Telegram We The People - Switzerland Chat [https://t.me/WeThePeople\\_Switzerland\\_Chat](https://t.me/WeThePeople_Switzerland_Chat).
- Once a week, all arrest warrants will be published collectively on our website.
- **(It is your decision whether or not to send the warrant to the accused by post).**

Step 5:

- If the harassment continues, send the accused the letter from the sample website "Attachment to Arrest Warrant" with a copy of the warrant.
- **A separate PDF file must be submitted for each case and each warrant.**

**Everyone is SELF-RESPONSIBLE for his/her writing! Remember, YOUR WORD IS YOUR BOND.**
